#### Purpose:

The Ammonia programme is available as part of a comprehensive suite of programmes to assess and monitor the performance of the Clinical Biochemistry laboratory's repertoire of both core and esoteric tests used for the diagnosis and monitoring of disease.

Ammonia is analysed as part of the diagnostic investigation of the unconscious patient, to support the diagnosis of Reye's syndrome and hepatic encephalopathy and in identification and management of a urea cycle defect.

#### Scope:

A range of Ammonia samples are distributed covering both normal and pathological levels including those seen in urea cycle defects. The material is liquid human serum, this matrix is commutable and compatible with all enzymatic methods assayed on laboratory analysers, dry slide chemistry analysers and Point of Care devices (POCT).



Three aqueous samples are distributed monthly, with a minimum of 36 samples distributed over the year covering a wide clinically relevant range. The samples consist of a panel of 6 linearly related samples distributed on a number of occasions over that period which are used to assess both laboratory and method performance, including linearity, bias, within and between batch imprecision.


#### Wegas Connect


All registration forms can now be found in the links below and all requests will be seamlessly progressed through the approval process once the request has begun on line.




Enrolment Process

#### Education & Training

#### Annual Conference

A two day meeting in the form of scientific seminars, management seminars and EQA workshops are organised annually with additional ad hoc workshops. The annual meetings include current hot topics within Laboratory Medicine and provide participants the opportunity to exchange views, to question the organisers and to discuss problems and strategies. Meetings are approved for CPD by both the IBMS and RCPath. The EQA workshops cover statistical analysis, interpretation of EQA and problem solving through interactive case studies. #### **POCT Training**

A number of POCT Training days are held throughout the year. The sessions provide essential tools for both point of care coordinators and users to provide a Quality and safe service.

POCT testing is often undertaken by non-laboratory trained personnel, mostly by nurses at the forefront of patient care. Weqas POCT training packages ensure nurses are confident, knowledgeable and competent in the delivery of point of care services. Their use should be supported by an appropriate management framework in partnership with an accredited pathology laboratory.


