

Day 1: Tuesday 12th December 2023

Theme: Point of care testing and the future of diagnostics



Chair: Prof. Garry John

Retired Consultant Clinical Biochemist

Garry has held senior positions in UK hospitals for 30 years and has driven change locally and nationally. In addition to leading the Department of Clinical Biochemistry within the Norfolk and Norwich University Hospital, he has been Clinical Director, Associate Medical Director and Director of Research. He is additionally an Honorary Professor in the Norwich Medical School. Garry has had an influence on scientific work nationally and internationally; he has served on ACB Council and his interest in quality has been demonstrated by his significant involvement in UK EQA Schemes (UKNEQAS and WEQAS).

But most notably Garry has had a long and successful association with the International Federation of Clinical Chemistry and Laboratory Medicine; he has chaired three active committees: first a Working Group (WG) on Haemoglobin A1c standardisation, the first WG to fully complete all tasks allocated; then chairing a Task Force on implementation of HbA1c standardisation where he worked closely with manufacturers and professional organisations achieving global standardisation. He also chaired a committee within the Educational Division on Education in the use of Biomarkers in Diabetes. He is widely recognised and respected within the scientific community and has a long experience in delivering results.

Theme: Point of care testing and the future of diagnostics



Chair: Prof. Pat Twomey

University College Dublin

Professor Patrick Twomey is consultant chemical pathologist in St. Vincent's University Hospital, Dublin, the Laboratory Director for Clinical Chemistry within the St Vincent's Hospital Group and Clinical Professor in the School of Medicine, University College Dublin. He obtained an Intercalated BSc in Biochemistry from University College Cork before being awarded his Medical degree. He is a Fellow of the Royal College of Physicians of Ireland, the Faculty of Pathology at the Royal

College of Physicians of Ireland and of the Royal College of Pathologists where he also is an examiner. He is the President of the UEMS Section of Laboratory Medicine (European Union Medical Specialists), Internal Auditor UEMS and National Speciality Director Chemical Pathology, Royal College of Physicians of Ireland. He has co-authored one text book, several book chapters and over 100 original publications in the fields of clinical biochemistry, metabolic medicine, lipids and nutrition. He is the Best Practice Editor of the Journal of Clinical Pathology and is a member of the editorial boards of the Journal of Clinical Pathology, the British Medical Journal Case Reports and the Clinical Biochemistry journal. He was previously the Vice Chair of the UK Joint Working Group on Quality Assessment in Pathology and past Chair of the Chemical Pathology National Quality Assurance Advisory Panel within the Royal College of Pathologists - currently he sits on the Vitamin D EQA Scheme (DEQAS) advisory panel and the Wales EQA Scheme (WEQAS) Steering Committee.

He runs clinical metabolic services for dyslipidaemia.

National Point of Care Testing Strategy Board

Recognising that emerging trends and technologies provide exciting opportunities for the pathology community to rethink approaches to the development and delivery of services in the future, the National Point of Care Testing Strategy Group is working to identify and establish a formal structured arrangement to deliver Point of Care Testing services in NHS Wales.

Point of Care Testing (POCT) relates to any medical diagnostic testing at the time and place of patient care.

It is an area of healthcare that is developing rapidly, with increased and improved connectivity and technological innovation. These advancements make 'near patient' results possible, with the potential to improve assessment and care management for the patient.

Having diagnosis closer to the patient can help manage life-threatening conditions, such as sepsis and infection control. It also helps patients to self-monitor chronic conditions, such as diabetes, without having to visit hospitals and GP surgeries.

Working with health board point of care testing services, the POCT Strategy Group will also oversee other areas of work, such as:

- improvements in the infrastructure to support national POCT systems;
- the development of POCT training and competencies for both laboratory and non-laboratory based staff; and
- promoting and championing the role and value of POCT, which will improve the consistency of the service throughout Wales, and help share best practice and the benefits of research.

Jonathan Harris

Jonathan graduated from the University of Ireland, Galway in 1997 with a degree in Physiology and Biochemistry. He obtained an honours degree specialising in Biochemistry with the University of Wolverhampton in the United Kingdom a year later.

He began his career in Blackrock Clinic, the largest and longest opened private hospital in Ireland as a Medical Scientist in Immunology. He diversified his interest

and worked in Biochemistry for 5 years. He went on to study a Masters in Biomedical Science with the University of Ulster in Coleraine, Northern Ireland.

He was employed as a Senior Medical Scientist in the Blood Sciences department at the Hermitage Medical Clinic in Dublin for 6 years which included responsibility for Point of Care Testing (POCT). He became a fellow of the Academy of Medical Laboratory Science in Ireland in 2012.

In 2014, he was employed as POCT Manager in the newly built Cleveland Clinic Abu Dhabi (CCAD). Jonathan was responsible for setting up and establishing the POCT department. The department achieved CAP accreditation within 6 months of opening. In 2016, the POCT program achieved ISO 22870 accreditation with the United Kingdom Accreditation Service, the first in the Middle East to achieve this. CCAD has the broadest POCT scope accredited to this standard internationally.

In 2019, Jonathan transferred to National Reference Laboratory where he continued to manage POCT at CCAD. In 2023, he was asked to lead a POCT centralization project across the Mubadala Health Enterprise. This will involve the creation of a dedicate POCT department, with centralization of all services associated with it.

Jonathan has produced a number of publications relating to POCT in journals and magazines. He is a regular contributor to conferences in the region. Jonathan completed a Masters with the Royal College of Surgeons Ireland in Healthcare Leadership & Innovation in 2021. He has also led the hosting of multiple dedicated POCT conferences in Abu Dhabi. The next one will be in April 2024.




